Terms and conditions for the Look for the RVMAP Key Giveaway

Eligibility

1. Information on how to enter and prizes form part of these terms & conditions. Any entry not complying with these terms and conditions is invalid.
2. Entry is open to residents of Australia, aged 18 and above. Employees and their immediate families of the Promoter and Sponsors including Caravan Industry Association of Australia and Dometic Australia, their related corporate bodies and Agencies are not eligible to enter this Promotion.
